**The Kampala Capital City (Commencement) Instrument, 2011.**

*(Under section 1 of the Kampala Capital City Act, Act No.1 of 2011)*

IN EXERCISE of the powers conferred on the Minister by section 1 of the Kampala Capital City Act, 2010, Act No. 1 of 2011, this Instrument is made this 1st day of March, 2011.

**1. Title.**

This Instrument may be cited as the Kampala Capital City (Commencement) Instrument, 2011.

**2. Commencement of Act No. 1 of 2011.**

The 1st of March, 2011 is appointed as the day on which the Kampala Capital City Act, 2010 shall come into force.
