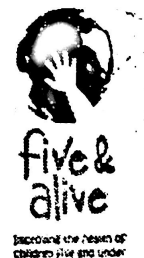

**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption)  
(No. 3) Order, 2011.**

*(Under sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361, this Order is made this 10th day of June, 2011.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) (No. 3) Order, 2011.

**2. Exemption.**

A person who drives a motor vehicle and competes in the KCB-Pearl of Africa Uganda Rally, organised by the Federation of Motor Sports Club of Uganda (FMU), scheduled to take place on 15th - 17th July, 2011 in Kampala, Wakiso, Buikwe, Kaunga and Mukono districts, is exempted from the provisions of section 120 of the Traffic and Road Safety Act, Cap. 361.

**3. Maximum speed limit.**

A person who drives a motor vehicle and competes in the KCB-Pearl of Africa Uganda Rally mentioned in paragraph 2, shall not exceed a maximum speed of one hundred and eighty kilometers per hour, for the duration of the rally.
