



The Traffic and Road Safety (Exemption from De-registration for Export Fees) Order, 2011.

(Under section 175 of the Traffic and Road Safety Act, 1988 Cap. 361)

IN EXERCISE of the powers conferred upon the Minister by section 175 of the Traffic and Road Safety Act, 1998, this Order is made this 12th day of April, 2011.

1. Title.

This Order may be cited as the Traffic and Road Safety (Exemption from De-registration for Export Fees) Order, 2011.

2. Exemption of Salini Costruttori SPA from re-exportation fees.

- (1) Salini Costruttori SPA is exempted from the difference in fees payable under the Traffic and Road Safety Act, 1998 by virtue of the Finance Act, 2006 and those payable under the Traffic and Road Safety Act, 1998 by virue of the Finance Act, 2009 in respect of de-registration for export, of vehicles and equipment specified in the Schedule.
- (2) For the avoidance of doubt, Salini Costruttori SPA is required to pay only the de-registration for export fees payable under the Traffic and Road Safety Act, 1998 by virtue of the Finance Act, 2006 in respect of the vehicles and equipment specified in the Schedule.
