(Under section 56(2)(c) of the Penal Code Act, Cap. 120).

IN EXERCISE of the powers conferred on the Attorney General by section 56(2)(c) of the Penal Code Act, Cap. 120, this Order is made this 4th day of April, 2012.

1. Title.

This Order may be cited as the Penal Code (Declaration of Unlawful Societies) Order, 2012.

2. Declaration of unlawful society.

Any society specified in the Schedule to this Order is declared to be a society dangerous to peace and order in Uganda.
