





**The Electoral Commission (Appointment of Date of Completion of
Update of Voters' Register in Specified Electoral Areas)
Instrument, 2012.**

Under Section 19(8)(c) of the Electoral Commission Act, Cap 140.

IN EXERCISE of the powers conferred upon the Commission under Section 19(8)(c) of the Electoral Commission Act, Cap. 140, this Instrument is made this 11th day of May, 2012.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Specified Electoral Areas), Instrument, 2012.

2. Appointment of date of completion of update.

The 1st day of June 2012 is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-elections to fill the existing local government council vacancies countrywide.

3. No application accepted after appointed date.
