LICENSE No. 094 FOR GENERATION AND SALE OF
ELECTRICITY TO SOUTH ASIA ENERGY
MANAGEMENT SYSTEMS LLC (SAEMS-LLC) –
NYAMWAMBA HYDRO POWER PROJECT (Under
the Electricity Act, 1999 Chapter 145 laws of Uganda)**

Pursuant to the provisions of Section 44 of the Electricity Act 1999 (Chapter 145 of Laws of Uganda), the Electricity Regulatory Authority hereby intends to amend License No. 094 for the Generation and Sale of Electricity issued to SOUTH ASIA ENERGY MANAGEMENT SYSTEMS LLC (SAEMS-LLC) – NYAMWAMBA HYDRO POWER PROJECT on the 10th day of January 2012 as detailed below.

1. Paragraph 3 of the Licence certificate is hereby amended by adding the words ‘*may be renewed and or...the Act and Regulations made there under and directives of the Authority*’ in the license certificate as follows;

This licence shall be effective as of the date written above and will continue in effect for a period of twenty (20) years unless and until such time as it may be renewed and or terminated earlier in accordance with the applicable provisions of the License, the Act and Regulations made thereunder and directives of the Authority.

2. By Introducing Section 10A as follows:

SECTION 10 A: RENEWAL

10A.1 The Licensee may, within three years before the expiry of the licence, apply in writing to the Authority for renewal of the period of the Licence. Any extension of the Licence period shall not in any case exceed 40 years from the Effective Date. For avoidance of doubt, the Effective Date shall mean the date of approval of the licence that is, the 10th day of January, 2012.

10A.2 The Authority may, at its sole discretion, extend the period of the licence on such terms and conditions determined by the Authority on payment to the Authority of the prescribed fees and provided there is no existing breach of the prevalent terms and conditions of this Licence.

10A.3 In considering an application for extension of the period of the Licence, the Authority shall have regard to the performance of

the Licensee during the existing period, and the maintenance of accurate records of the Generation Complex in accordance with Prudent Utility Practices.

10A.4 The Authority shall at the time of renewal of the Licence period, prescribe the Tariff applicable for the extended period and shall take into account the fact that the Licensee would have already recovered its capital costs during the initial 20 (Twenty) year term of the licence and therefore prescribe a Tariff that is sufficient to cover the licensee’s reasonable operation and maintenance costs incurred by the Licensee during the extended period.

10A.5 The Licensee may decline to renew the license following the expiry of the initial 20 (Twenty) year term of the Licence.

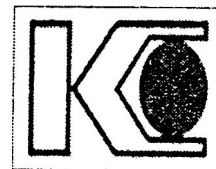

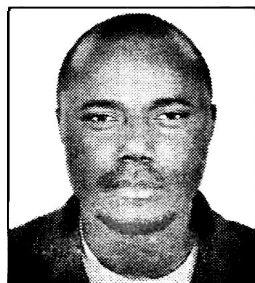
