

IN EXERCISE of the powers conferred upon the Minister under section 19(8) (b) of the Electoral Commission Act, this Instrument is made this 4th day of January, 2013.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Butalejja District) Instrument, 2013.

2. Appointment of completion of date.

The 9th day of January, 2013, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election of Woman Member of Parliament for Butalejja District.

3. No application after completion date.

The Electoral Commission shall not accept any application to register as a voter or to transfer to a new voting location for the purposes of the Butalejja District by-election for Woman Member of Parliament, after the date specified in paragraph 2.
