**The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in the Specified Local Government Council Electoral Areas in Pallisa District) Instrument, 2013.**

*(Under section 19(8) (c) of the Electoral Commission Act, Cap. 140)*

IN EXERCISE of the powers conferred upon the Commission under section 19(8) (c) of the Electoral Commission Act, Cap. 140 (as Amended), this Instrument is made this 22nd day of April, 2013.

**1. Title.**

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in the Specified Local Government Council Electoral Areas in Pallisa District) Instrument, 2013.

**2. Appointment of completion of registration.**

The 2nd day of May, 2013 is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the Local Government Council By election and Elections in—

- (a) Kanginima Sub County;
- (b) Kakoro Sub County;
- (c) Petete Sub County.

**3. No application accepted after appointed date.**

For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from Pallisa District shall be accepted by the Electoral Commission seeking—
