The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Butebo Constituency, Pallisa District) Instrument, 2013.

(Under section 19(7) and (8)(b) of the Electoral Commission Act, Cap. 140)

IN EXERCISE of the powers conferred upon the Minister by section 19(7) and (8)(b) of the Electoral Commission Act, this Instrument is made this 29th day of April, 2013.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Butebo Constituency, Pallisa District) Instrument, 2013.

2. Appointment of date of completion of updating register.

The 2nd day of May, 2013, is appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for the purposes of the by-election for Member of Parliament for Butebo Constituency, Pallisa District.

3. No application after appointed date.

The Electoral Commission shall not accept any application to register as a voter or to transfer to a new voting location for the purposes of Butebo Constituency, Pallisa District by-election for Member of Parliament, after the date specified in paragraph 2.

S T A T U T O R Y I N S T R U M E N T S**2013 No. 16.****The Traffic and Road Safety (Speed of Motor Vehicle) (Temporary Maximum Speed Limit) (No. 3) Order, 2013.***(Under sections 135 and 175 of the Traffic and Road Safety Act, 1998, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 135 and 175 of the Traffic and Road Safety Act, 1998, Cap. 361, this Order is made this 18th day of April, 2013.

1. Title.

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Temporary Maximum Speed Limit) (No. 3) Order, 2013.

2. Temporary maximum speed limit.

A temporary maximum speed limit is prescribed up to a limit of 180km per hour for drivers of motor vehicles, who compete in the MPU Masaka Rally 2013 to be held on the 3rd to 5th May, 2013.

3. Exemption.

Subject to paragraph 2, a person who drives a motor vehicle and who competes in the MPU Masaka Rally 2013, to be held on the 3rd to 5th May, 2013 in Masaka, Lwengo, Kalungu and Bukomansimbi Districts organised by the Federation of Motor Clubs of Uganda (FMU), in conjunction with Motorsport Club, is exempted from the provisions of section 120 of the Traffic and Road Safety (Speed Limits) Regulations, S.I No. 33 of 2004 for the duration of the rally.
