IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 34(f)(ii) and 178 of the Traffic and Road Safety Act, 1998, Cap. 361, these Regulations are made this 19th day of August, 2013.

**1. Title.**

These Regulations may be cited as the Traffic and Road Safety Act (Fees) (Motor Vehicle Registration Number Plates) Regulations, 2013.

**2. Fees.**

These fees payable in Uganda shillings for different categories of motor vehicles and registration plates to a manufacturer and supplier of motor vehicle registration number plates are prescribed in the schedule.
