APPLICATION BY UGANDA ELECTRICITY TRANSMISSION COMPANY LIMITED (UETCL) FOR A MULTI YEAR REVENUE REQUIREMENT FOR THE PERIOD 2014-2016

The Electricity Regulatory Authority ('the Authority') has under the provisions of the Electricity Act 1999, Regulations 14 and 16 of the Electricity (Application for Permit, License and Tariff Review) Regulations, 2007, received an application from UETCL for a Multi-Year Revenue Requirement for the Period 2014-2016.

Reasons for the changes

The multi-year application is envisaged to incentivise UETCL to improve its efficiency by providing for it adequate revenue requirements over a period of three (3) years. It will also reduce on the time taken to review the UETCL applications on an annual basis as has been the case, enabling the company to concentrate on its core activities.

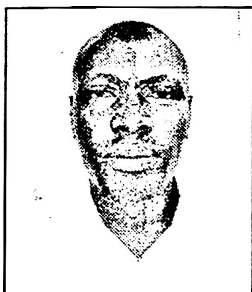
