APPLICATION FOR A LICENSE FOR THE ESTABLISHMENT OF A 83 MW HYDROPOWER PLANT IN PADER AND GULU DISTRICTS

Under sections 33 & 35 of the Electricity Act, 1999, Cap. 145 (the Act) and Regulations 7 & 8 (2) (d) of the Electricity (Application for Permit, Licence and Tariff Review) Regulations, 2007 (the Regulations).

The Electricity Regulatory Authority ('the Authority') has received an application for a Generation and Sale license from PAC S.p.A trading as ARPE Limited.

The License will enable PAC S.p.A trading as ARPE Limited construct, generate and sell 42 MW and 41 MW of electricity from hydro power plants proposed to be established across River Achwain Burlobo village, Angagura Sub-county, Pader and Gulu Districts. The generated power will be sold to Uganda Electricity Transmission Company Limited and fed into the national grid.

The Core Consumer Price Index (CPI) increased from 208.2 in the Base Period to 208.32 in the month of February, 2014 as published by the Uganda Bureau of Statistics. The United States Producer Price Index (PPI) increased from 186.2 in the Base Period to 187.9 in the month of February, 2014, as published by the United States Bureau of Labor Statistics.
