### APPLICATION FOR A LICENSE FOR THE ESTABLISHMENT OF A 11.9MW BAGASSE CO-GENERATION POWER PLANT IN KALIRO DISTRICT

The Electricity Regulatory Authority ('the Authority') has received under Section 33 of the Electricity Act, 1999, Cap. 145, ('the Act') and Regulation 7 of the Electricity (Application for Permit, Licence and Tariff Review) Regulations, 2007, an Application for a Generation and Sale License from Sugar and Allied Industries Limited.

The License will enable Sugar and Allied Industries Limited to generate 11.9 MW of electricity from a bagasse co-generation power plant proposed to be established in Bwayuya, Namugongo Sub-county, Kaliro District. The Company will use 5.0MW internally and 6.9MW will be sold to Uganda Electricity Transmission Company Limited and fed into the national grid.
