





The Stamps (Exemption from Stamp Duty) (Increase of Issued Share Capital by Pride Microfinance Limited (MDI)) Instrument, 2014.

(Under section 10 of the Stamps Act, Cap. 342).

IN EXERCISE of powers conferred upon the Minister responsible for Finance under section 10 of the Stamps Act, this Instrument is made this 4th day of April, 2014.

1. Title.

This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Increase of Issued Share Capital by Pride Microfinance Limited (MDI)) Instrument, 2014.

2. Exemption from stamp duty.

The stamp duty chargeable under section 2 of the Act and payable by Pride Microfinance Limited (MDI) on the increase of its issued share capital from UGS 20,000,000,000 to UGS 60,000,000,000 is exempted.

**The Traffic And Road Safety (City Bus Services) (Amendment)
Regulations, 2014.**

(Under sections 71 and 178 of the Traffic and Road Safety Act, Cap. 361)

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 71 and 178 of the Traffic and Road Safety Act, Cap. 361, these Regulations are made this 4th day of July, 2014.

1. Title.

These Regulations may be cited as the Traffic and Road Safety (City Bus Services) Regulations, 2014.

2. Amendment of S.I. No. 7 of 2011.

The Traffic and Road Safety (City Bus Services) Regulations, 2011. are amended in regulation 2 by substituting for the definition of Council the following—

““Council” means the Kampala Capital City Authority or any other local authority;”

3. Replacement of Regulation 3.

S.I. No. 7 of 2011 is amended by replacing for regulation 3 the following—

“3. Application.

These Regulations shall apply to the whole of Uganda.”
