

**The Stamps (Exemption from Stamp Duty) (Lease of Property to GIZ)  
Instrument, 2014.**

*(Under section 10(a) of the Stamps Act, Cap 342).*

IN EXERCISE of the powers conferred on the Minister responsible for finance by section 10(a) of the Stamps Act, this Instrument is made this 1st day of September, 2014.

**1. Title.**

This Instrument may be cited as the Stamps (Exemption from Stamp Duty) (Lease of Property to GIZ) Instrument, 2014.

**2. Exemption from stamp duty.**

GIZ is exempted from the payment of the stamp duty chargeable under section 2 of the Act in respect of the renewal of lease on property comprised in LRV 170 Folio 19 No. 23 Nakasero Road, Kampala.
