The Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Busia District) Instrument, 2014.

(Under section 19(8) (c) of the Electoral Commission Act, Cap. 140)

IN EXERCISE of the powers conferred upon the Commission under Section 19 (8)(c) of the Electoral Commission Act, Cap 140 (as Amended), this Instrument is made this 4th day of November, 2014.

1. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Busia District) Instrument, 2014.

2. Appointment of completion of registration.

The 17th day of November, 2014, is hereby appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-elections of the District Chairperson and filling of existing vacancies in various Local Government Councils in Busia District.

3. No application accepted after appointed date.

For purposes of paragraph 2 of this Instrument, after the appointed date, no application form from Busia District shall be accepted by the Electoral Commission seeking—
