The Electricity Regulatory Authority ('the Authority') has under Section 33 of the Electricity Act, 1999, Cap. 145, ('the Act') and Regulation 7 of the Electricity (Application for Permit, Licence and Tariff Review) Regulations, 2007 received an Application for an electricity Generation and Sale License from **MSS Xsabo Power Limited**.

The License will enable MSS Xsabo Power Limited to generate 20MW of electricity from a Solar Photovoltaic power plant proposed to be established in Namulasa Village, Butiti Parish, Kabulasoke Sub-County, Gomba District and 20MW of electricity from a wind power plant proposed to be established in Katerema Village, Osiya Parish, Rubongi Sub-County, Tororo District.
