**PRACTICE NOTES**

**URA/PN/ TREATMENT OF RENTAL INCOME AND INCOME FROM EDUCATIONAL INSTITUTIONS EFFECTIVE 1st JULY, 2014.**

The Commissioner General of Uganda Revenue Authority hereby issues these practice notes under Section 160 of the Income Tax Act, CAP. 340 of the Laws of Uganda for the guidance of staff and taxpayers.

**(i) Treatment of Rental income following the Income Tax (Amendment) Act, 2014.**

Section 3 of the Income Tax (Amendment) Act, amended Section 5(3) of the Income Tax Act was amended to provide that "The tax imposed under this section on any person is separate from the tax imposed under section 4 and –

- a) The rent derived by a person shall not be included in the gross income of the person which is subject to tax under this Act for any year of income;
- b) Expenditures and losses incurred by the individual in the production of the rent shall be allowed as a deduction under this Act for any year of income only as provided for in Section 22 (1)(c);
- c) Expenditures and losses incurred by a person, other than an individual, in the production of rent shall be allowed as a deduction under this Act for any year of income; and
- d) Expenditures and losses incurred by a partnership in the production of rent shall be allowed as a deduction under this Act for any year of income only as provided in section 22 (1) (c).

Effective 1st July 2014 rental income earned by any person liable to tax, that is: an Individual, Company, Partnership, Trust, Retirement fund, shall be taxed separately from other forms of income.

The above change affects the rental income earned by all persons effective 1st July, 2014. For the avoidance of doubt, this change applies to years of income commencing on or after 1st July, 2014.

Therefore, persons other than individuals whose years of income commenced before 1st July, 2014 shall NOT be required to separate their rental income from other income, for the years of income commencing before 1st July, 2014.

Consequently,

- 1) Persons whose years of income commenced after 1st July, 2014 shall be required to separate their rental income from any other income and file separate returns for each class of income;
  - 2) The new returns to cater for the change in the Law will be available on our web portal (<http://ura.go.ug/>) effective 01/07/2015 to cater for this change.
- (ii) Treatment of income derived from educational institutions following the Income Tax (Amendment) Act, 2014**

Section 8 of The Income Tax (Amendment) Act 2014 repealed Section 21(1) (aa) which exempted the "business income derived by a person from managing or running an educational institution" from tax.

The implications of the repeal are:

- 1) Effective 1st July, 2014 Business income derived from the running and managing of educational institutions is taxable;
- 2) Our Practice Notes issued on 16th March, 2009 referenced as URA/IT/PN/1/09: **exempt income derived by a person from managing or running an educational institution** to the extent to which it refers to income derived from running educational institutions is hereby revoked;
- 3) Persons' income which was derived from running or managing Educational institutions for years commencing before 1st July, 2014 is still exempt until the end of the taxpayer's year of income; and
- 4) Persons' Income derived from running or managing Educational institutions for years of income commencing on or after 1st July, 2014 is taxable.
