NOTICE OF MODIFICATION of

LICENSE CONDITIONS FOR GENERATION AND SALE OF ELECTRICITY

of License No. 113

Issued to

RWIMI EP COMPANY LIMITED ('Licensee')

IN EXERCISE of its powers under Section 44 (4) of the Electricity Act, 1999 (herein after referred to as the 'Act'), the Electricity Regulatory Authority (herein after referred to as the 'Authority') hereby gives notice under Section 44 (5) of the Act of the Modification (Modification No.2) of the License No. 113, issued to **RWIMI EP COMPANY LIMITED**, for the Generation and Sale of Electricity as follows:

1. Clause 1.1 'Definition' is modified as follows;

1.1 By extending Financial Close by a period of sixty (60) days and therefore replacing the words '*four hundred and twenty (420) days*' in the definition of 'Financial Close' with the words '*four hundred and eighty (480)*' as follows:

Financial Close the date, not later than four hundred and eighty (480) days, from the Effective Date on which the Licensee would have concluded financial arrangements and disbursements by the lenders and by which the lenders confirm that all conditions precedent to first drawdown have been satisfied or waived.

1.2 By modifying the definition of '*Scheduled Construction Start Date*' from sixty (60) days from Financial Close to Ten (10) days from Financial Close as follows:

Scheduled Ten (10) days from Financial Close.
Construction Start
Date

2. Clause 14 'OBLIGATION TO PROVIDE PROOF OF FINANCIAL CLOSE' is modified by replacing the words '*four hundred and twenty (420) days* with the words '*four hundred and eighty (480) days*' and the words '*to be agreed between*' with the words '*as may be approved by*' as follows:

11 OBLIGATION TO PROVIDE PROOF OF FINANCIAL CLOSE

The Licensee shall provide proof of Financial Close to the Authority within four hundred and eighty (480) days from the Effective Date, or within such period as may be approved by the Authority. In the event that the Licensee does not provide proof of the said Financial Close, the License shall terminate automatically.

3. By modifying clause 4.1.1.2 on performance bonds by extension of the period within to achieve Commercial Operations Date from twenty months from the Scheduled Construction Start Date to twenty four months from the Scheduled Construction Start Date as follows:

4.1.1.2 Commercial Operations Date, within a period not exceeding twenty four (24) months from the Scheduled Construction Start Date in respect of which the value of the Performance Bond shall be the equivalent of USD 2,500 per MW of Generation Capacity.

4. The Authority has pursuant to Section 44 (5) (a) of the Act published this notice and the Modification shall take effect within thirty days from 7th September, 2015 if no representations or objections are received.

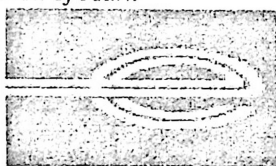


