NOTICE OF INTENDED MODIFICATION OF LICENSE FOR GENERATION AND SALE OF ELECTRICITY No. 119 ISSUED TO MUVUMBE HYDRO (U) LIMITED ('LICENSEE').

IN EXERCISE of its powers under Section 43 (3) and (6) of the Electricity Act, 1999 (herein after referred to as the 'Act'), the Electricity Regulatory Authority (herein after referred to as the 'Authority') hereby gives notice under Section 43(6) of the modification of License No. 119 issued to MUVUMBE HYDRO (U) LIMITED for the Generation and Sale of Electricity as follows;

The modification of:

- Condition 1.1 on definition of Financial Close by extending it from one hundred and eighty (180) days to two hundred and seventy (270) days; and
- Condition 1.1. by including a definition of Scheduled Construction Start Date; and
- Condition 4.1.1.1 by capitalizing the first letter of each of the words "scheduled construction start date" and by including the words "...of Generation Capacity..." after the Performance Bond amount: and
- Condition 4.1.1.2 by deleting the words ..." 30 (thirty) months from the Effective Date..." and replacing the deleted words with the words "..twenty four (24) months from the Scheduled Construction Start Date..." and by including the words "...of Generation Capacity..." after the Performance Bond amount; and
- 5. Condition 14 by deleting the words "...180 (One Hundred and Eighty days) and replacing the deleted words with the words "...two hundred and seventy

- (270) days and by deleting the words " to be agreed between the Licensee and the Authority..." and replacing the deleted words with the words "...as may be approved by the Authority..."
- Annex C on the format for performance Bonds by deleting the Annex in its entirety and replacing it with a revised Performance Bond format.

NOTICE OF INTENDED MODIFICATION LICENSE FOR GENERATION AND SALE OF ELECTRICITY No. 094 ISSUED TO AFRICA EMS **NYAMWAMBA LIMITED ('LICENSEE')** 

IN EXERCISE of its powers under Section 44 (4) and (5) of the Electricity Act, 1999 (herein after referred to as the 'Act'), the Electricity Regulatory Authority (herein after referred to as the 'Authority') hereby gives notice under Section 44(5) of the intended modification of License 094 issued to AFRICA EMS NYAMWAMBA LIMITED for the Generation and Sale of Electricity as follows;

To modify condition 2.4.6 of the License to provide for the commencement of construction as the 1st day of October, 2015 and condition 1.5 to extend the Commercial Operations Date (COD) from 27 months after the Effective Date to not later than 30<sup>th</sup> of September, 2017; and

- To restate the License in accordance with the Authority decisions made at the Authority meetings No. 225, 221 and 219; that is; the transfer of the License from South Asia Energy Management Systems (SAEMS - LLC) to Africa EMS Nyamwamba Limited, the modification of the installed capacity of the plant from 14MW to 9.2MW and the revision of the applicable REFiT for HPP between 0.5MW and 20 MW from USc 0.079/kWh to USc 0.085/kWh; and
- To require the Licensee to post a performance bond of USD 2,500 MW in respect of achieving Commercial Operations Date and USD 5,000 per MW in respect of achieving Financial Close and commencement of construction not later than 30 days from the date of issuance of the modification.
