[Under Section 10 of the Electricity Act, 1999 and Regulation 3, Code 2.5 of the Schedule to the Electricity (Primary Grid Code) Regulations, 2003]

**ELECTRICITY (ELECTRICAL NETWORK
FACILITIES) STANDARDS**

1. BACKGROUND

This Directive No. ERA/001/2016 of the Electricity Regulatory Authority (the Authority) is issued pursuant to the Electricity Act, 1999 (the Act) and in particular Section 10 (e) of the Act, which empowers the Authority to make and enforce directions to ensure compliance with licences issued under the Act.

The Authority is required and committed to ensure efficient management, quality and uniformity of electricity supply in Uganda.

Pursuant to Section 10 (i) (j) (p) of the Act, the Authority has the mandate to:

- (a) develop and enforce performance standards for the generation, transmission and distribution of electricity;
- (b) encourage the development of uniform electricity industry standards and codes of conduct, and;
- (c) approve standards for the quality of electricity supply services provided.

Regulation 3, Code 2.5 of the Schedule to the Electricity (Primary Grid Code) Regulations, 2003 requires all installations, equipment, plant or apparatus to comply with Uganda National Bureau of Standards and Codes of Practice or in their absence, the IEE or British and IEC Standards.

The Authority has observed that installations, equipment, plant and apparatus being used in the Electricity Supply Industry (ESI) are not uniform in standard and quality.

2. RATIONALE

In order to ensure uniformity and quality, all installations, equipment, plant and apparatus being used in the Electricity Supply Industry (ESI), shall comply with the current version of national electricity standards, as may be amended, reviewed or revised from time to time.

The standards adopted shall apply to the following electrical facilities:—

- (a) Transformers;
- (b) Fuses;
- (c) Overhead line conductors;
- (d) Poles;
- (e) Metering;
- (f) Lightning;
- (g) Switch Gear, and;
- (h) Cables.
