IN EXERCISE of the powers conferred upon the Minister by section 19 (7) and (8) (b) of the Electoral Commission Act, this Instrument is made this 5th day of April, 2017.

**1. Title.**

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of Update of Voters' Register in Kagoma County Constituency, Jinja District), Instrument, 2017.

**2. Appointment of date of completion of registration.**

The 10th day of April, 2017, is appointed as the date upon which the Commission shall complete the exercise of updating the Voters' Register for the purpose of the by-election of Member of Parliament, Kagoma County Constituency, Jinja District.

**3. No application accepted after appointed date.**

The Electoral Commission shall not accept any application to register as a voter or to transfer to a new voting location for the purposes of Kagoma County Constituency, Jinja District by-election for Member of Parliament, after the date specified in paragraph 2.
