IN EXERCISE of the powers conferred upon the Minister by section 19(7) and (8)(b) of the Electoral Commission Act, this Instrument is made this 24th day of May, 2017.

1. Commencement.

This Instrument shall come into force on 24th day of May, 2017.

2. Title.

This Instrument may be cited as the Electoral Commission (Appointment of Date of Completion of the Update of Voters' Register in Kyadondo East Constituency, Wakiso District), Instrument, 2017.

3. Appointment of date of completion of registration.

The 26th day of May, 2017, is appointed as the date on which the Commission shall complete the exercise of updating the Voters' Register for purposes of the by-election of Member of Parliament, Kyadondo East Constituency, Wakiso District.

4. No application accepted after appointed date.

The Electoral Commission shall not accept any application to register as a voter or to transfer to a new voting location for purposes of the Kyadondo East Constituency, Wakiso District by-election for Member of Parliament, after the date specified in paragraph 2.
