**The Land Acquisition (Tilenga Project) Instrument, 2018.**

*(Under section 3 of the Land Acquisition Act, Cap. 226)*

IN EXERCISE of the powers conferred upon the Minister responsible for lands, by section 3 of the Land Acquisition Act, Cap. 226, this Instrument is made this 21<sup>st</sup> day of August, 2018.

**1. Title.**

This Instrument may be cited as the Land Acquisition (Tilenga Project) Instrument, 2018.

**2. Declaration of land required for public purpose.**

(1) The parcels of land described in Part 1 of the Schedule to this Instrument are declared as land required by the Government for the construction of the Tilenga Project.
