2019 No. 1.

The Financial Institutions (Appraised Book Value) Regulations, 2019.

*(Under sections 88(2)(c) and 131(1m) of the Financial Institutions Act,
Act 2 of 2004)*

IN EXERCISE of the powers conferred upon the Central Bank by sections 88(2)(c) and 131(1m) of the Financial Institutions Act, 2004, and in consultation with the Minister responsible for finance, these Regulations are made this 23rd day of November, 2018.

1. Title

These Regulations may be cited as the Financial Institutions (Appraised Book Value) Regulations, 2019.

2. Application

These Regulations apply to financial institutions in Uganda engaged in repo transactions or transactions under the Global Master Repurchase Agreement adopted by the financial institutions.

3. Interpretation

In these Regulations, unless the context otherwise requires—

“Act” means the Financial Institutions Act, 2004;

“appraised book value” means the price of an instrument in the market place on the contract date;

“contract date” means the date on which the transaction details are agreed;

“haircut” means a risk adjustment to appraised book value in determining the purchase price in a repo transaction;

“instrument” means Government treasury bills or Government treasury bonds issued by the Government of Uganda;

“purchase price” means the appraised book value adjusted for instrument liquidation and other possible future losses on the instrument, potentially in stressed market conditions;

“repo transaction” means a transaction in which one party, referred to as seller, sells instruments to the other party, referred to as buyer, against the transfer of funds by the buyer, with a simultaneous agreement by the buyer to sell to the seller equivalent instruments at a date certain or on demand against the payment of funds by the seller;

“Treasurers’ Forum” means the committee established under the Uganda Bankers Association whose members include—

- (a) the Chairman of the Association Cambiste International (ACI) Uganda – the Financial Markets Association;
- (b) the Head of Treasury of commercial banks in Uganda; and
- (c) the Coordinator of ACI Uganda – the Financial Markets Association;

“value date” in relation to a repo transaction means the date on which the transaction is to be executed.

4. Ascertainment of appraised book value

(1) Subject to subregulation (2) and (3), a repo transaction is deemed to have been considered at appraised book value if it satisfies the following—

- (a) the price is derived from the yield curve, published daily by the Central Bank, and the data used for this purpose is sourced from published benchmark security quotes by financial institutions and interpolated for each outstanding security;
- (b) the date for determination of the appraised book value is the contract date and not the value date; and

- (c) that haircuts shall be reviewed monthly from a risk perspective and published by the Treasurers' Forum.

(2) Where a treasury bond is the instrument that is the subject of a transaction under subregulation (1), the financial institution shall determine the appraised book value in accordance with the following formula—

- (a) purchase price = market value x (1-haircut)
- (b) dirty market value = (clean price from yield curve + accrued interest) x $\frac{\text{par value}}{100}$
- (c) accrued interest = $\frac{\text{coupon rate}}{2} \times \frac{\text{current date} - \text{last coupon date}}{\text{next coupon date} - \text{last coupon date}}$

(3) Where a treasury bill is the instrument that is the subject of a transaction under subregulation (1), the financial institution shall determine the appraised book value in accordance with the following formula—

- (a) purchase price = market value x (1- haircut);
- (b) market value = (price from yield curve) x $\frac{\text{par value}}{100}$
