

The Security Organisations (Terms and Conditions of Service) (Amendment) Regulations, 2020.

(Under sections 9 and 12(b) of the Security Organisations Act Cap 305)

In EXERCISE of the powers conferred upon the Minister responsible for security, by sections 9 and 12 (b) of the Security Organisations Act, Cap 305, these Regulations are made this 20th day of April, 2020.

1. Title

These Regulations may be cited as the Security Organisations (Terms and Conditions of Service) (Amendment) Regulations, 2020.

2. Amendment of S.I. 305-1

The Security Organisations (Terms and Conditions of Service) Regulations, are amended by inserting immediately after regulation 32 the following—

"32A. Benefits of an employee that was due to retire between 1" July, 2009 and 1" July 2017.

(1) An employee who was due to retire between 1st July, 2009 and 1st July 2017, but continued in service of the security organisation shall be—

- (a) deemed to have retired on 1st July, 2017; and
- (b) paid his or her pensionable emoluments in accordance with these Regulations.
- (2) The period of continued service after 1st July 2017 shall be a special service on contract as provided in regulation 33."
