

# **CONSENT JUDGEMENT / DECREE**

BY CONSENT OF THE PLAINTIFFS AND THE 2<sup>ND</sup> AND 3<sup>RD</sup> DEFENDANTS, IT IS HEREBY agreed that the above suit, namely HCCS NO. 285 OF 2017, Prince Semakokiro Henry Kalemera & 2 Ors Vs. Prince David Namugala Mawanda & 2 Others, be and is hereby partially settled as follows:

- That the 2<sup>nd</sup> and 3<sup>rd</sup> defendants be and are hereby retained as administrators of H.H. Sir Daudi Chwa's estate, and the above suit should therefore proceed to determine whether or not the 1<sup>st</sup> defendant be removed as administrator of the same estate.
- That four (4) new additional administrators be, and are hereby appointed to manage H.H. Sir Daudi Chwa's estate. These include Prince Kalemera Henry Harrith Kimera, Prince David Nakibinge, Princess Diana Teyagala and Prince Semakokiro Henry Kalemera.
- That in the event that the court removes the 1<sup>st</sup> defendant as administrator, Princess Luswata Nawati Deborah

be appointed in his stead as the fifth new additional administrator making a total of seven administrators of H.H. Sir Daudi Chwa's estate.

- 4. That the names on the new letters of administrators to be issued pursuant to this consent shall be reflected as follows: Prince Kalemera Henry Harrith Kimera, Prince Moses Luswata Kimera, Prince David Nakibinge, Nalinya Gladys Nandawula Kyakuse, Princess Diana Teyagala, Prince Semakokiro Henry Kalemera and, where the 1<sup>st</sup> defendant is removed by court, Princess Deborah Nawati Luswata.
- 5. That all processes started by the majority of family members under the Committee of Royals led by Prince Kalemera Harrith Kimera Henry, including agreements made with third parties, to collect and recover properties of Sir Daudi Chwa whereby some deed prints for 196 square miles of land have already been produced, and to cause realignment of Sir Daudi Chwa's estate shall not be interrupted and the Parties to this consent hereby irrevocably authorize the third Parties to continue the process to conclusion without any form of interruption and or hinderance.
- 6. For the avoidance of doubt, the Parties to this consent hereby pledge to fully co-operate with the said third parties in collecting and recovering the properties of Sir Daudi Chwa's estate.
