

1. The Electricity (Acquisition and Use of Wooden Poles in the Electricity Supply Industry) Guidelines, 2020 were Approved by the Authority on 17th August, 2020, and they can be accessed at <https://www.era.or.ug/index.php/resource-centre/regulatory-instruments/guidelines-and-standards>.
