**The National Social Security Fund (Midterm Access to Benefits)  
Regulations, 2022**

*(Under section 20A (4) of the National Social Security Fund Act.  
Cap. 222)*

IN EXERCISE of the powers conferred upon the Minister responsible for social security by section 20A (4) of the National Social Security Fund Act, and in consultation with the board of directors of the National Social Security Fund, these Regulations are made this 2nd day of March, 2022.

PART I—PRELIMINARY

**1. Title**

These Regulations may be cited as the National Social Security Fund (Midterm Access to Benefits) Regulations, 2022.

**2. Purpose of Regulations**

The purpose of these Regulations is to prescribe the terms and conditions and procedure for accessing midterm benefits from the fund.

**3. Interpretation**

In these Regulations, unless the context otherwise requires—

“Act” means the National Social Security Fund Act, Cap. 222;

“benefit” means a benefit payable under the Act;

“board” means the board of directors of the fund;

“disability” means a substantial functional limitation of a person’s daily life activities caused by physical, mental or sensory impairment and environment barriers, resulting in

limited participation in society on equal basis with others and includes an impairment specified in Schedule 3 to the Persons With Disabilities Act, 2020;

“fund” means the National Social Security Fund established under section 2 of the Act;

“member” means a person who is registered as a member of the fund under the Act;

“midterm access” means access to a benefit under section 20A of the Act;

“person with disability” means a person who has a disability.

## PART II—QUALIFICATIONS AND APPLICATION FOR MIDTERM ACCESS TO BENEFITS

### **4. Qualifications for midterm access to benefits**

(1) A member who has made contributions to the fund shall be allowed midterm access to his or her benefits accrued from the contributions in accordance with these Regulations.

(2) A member who is forty-five years of age and above and who has made contributions to the fund under section 7 of the Act for at least ten years, is eligible to midterm access to his or her benefits, of a sum not exceeding 20 percent of his or her accrued benefits.

(3) A member who—

(a) is a person with disability;

(b) is forty years of age and above; and

(c) has made contributions to the fund under section 7 of the Act for at least ten years,

is eligible to midterm access, of a sum of 50 percent of his or her accrued benefits.

**5. Application to access benefits under section 20A (1) and (2) of the Act**

(1) An application for midterm access to benefits under section 20A (1) and (2) shall be made to the fund in the form set out in the Schedule to these Regulations.

(2) An application under subregulation (1) shall be accompanied with—

- (a) a copy of a national identification card, aliens' identification card or, where applicable, asylum seeker or refugee registration documents issued by the Office of the Prime Minister;
- (b) indication of the preferred method of payment including through a bank account, by mobile money or by any other method approved by the board; and
- (c) the National Social Security Fund Number.

**6. Application to access benefits by persons with disabilities under section 20A (3)**

(1) A determination of disability for the purposes of these Regulations shall be done in accordance with the Persons With Disabilities Act, 2020.

(2) A person with disability who wishes to access midterm benefits under section 20A (3) of the Act and these Regulations shall apply to the fund in the form set out in the Schedule to these Regulations.

(3) An application under subregulation (2) shall be accompanied with—

- (a) a copy of a national identification card, aliens' identification card or, where applicable, asylum seeker or refugee registration documents issued by the Office of the Prime Minister;

- (b) an indication of the preferred method of payment: including through a bank account, by mobile money or by any other method approved by the board;
- (c) the National Social Security Fund Number; and
- (d) a medical or expert report confirming the disability.

(4) A person with disability who is not able to fill the application form due to his or her disability may be assisted by a person of his or her choice.

(5) The fund may, in considering an application by a person with disability, verify the medical or expert report submitted under subregulation (3) (d).

## **7. Consideration of application by fund**

(1) The fund shall, on receipt of an application under regulation 5 or 6, review the application and—

- (a) where the application is complete, verify and determine whether the applicant qualifies for midterm access to benefits; and
- (b) where the application is incomplete, require the applicant to provide the additional information.

(2) Where, after verification under subregulation (1) (a), an applicant qualifies for midterm access to benefits, the claim shall be expeditiously processed and paid, but in any case not later than forty-five working days from the date of receipt of the application.

(3) Where, after verification under subregulation (1) (a), an applicant does not qualify for midterm access, the application shall be rejected and the fund shall immediately, but in any case not later than forty-five working days from the date of the application, notify the applicant in writing, stating the reasons for the rejection.

**8. Computation of accrued benefits**

For the purposes of midterm access to benefits under section 20A of the Act, the accrued benefits shall be calculated on the basis of the balance standing on the account of a member at the time of payment.

**9. Mode of payment**

The accrued benefits under these Regulations shall be paid into a bank account or mobile money account as indicated by the member or through any other mode of payment approved by the board.

**10. Terms and conditions for access to midterm benefits**

The following terms and conditions apply to midterm access to benefits under these Regulations—

- (a) a member shall not access midterm benefits under both section 20A (2) and 20A (3) of the Act; and
- (b) payment of the benefits shall be in accordance with the mode of payment specified by the applicant in the application.




