The Electricity Regulatory Authority has under section 29 of the Electricity Act 1999, Chapter 145 of the Laws of the Republic of Uganda (2000) received a notification for intended application for a licence from Electro-Maxx (U) Ltd for the generation and sale of electricity.

Electro-Maxx (U) Ltd intends to build, commission, own and operate a thermal generation power plant of 50MW initial capacity. The proposed location is at Mutundwe Substation for Uganda Electricity Transmission Company Ltd (UETCL) or any other site in Kampala.

The thermal plant will use heavy fuel oil (HFO), and generate power for supply into the national grid with the agreement of UETCL. The power plant will be using medium speed HFO engines, and the generating capacity could subsequently be increased to 200MW subject to demand and developments in the hydro-power generation at other sites elsewhere.

The External Trade (Importation Licence) (No. 9)  
(Amendment) Order, 2006.

(Under section 5 of the External Trade Act, Cap. 88).

IN EXERCISE of the powers conferred on the Minister by section 5 of the External Trade Act, this Order is made this 6th day of January, 2006. Cap. 88.

1. This Order may be cited as the External Trade (Importation Licence) (No. 9) (Amendment) Order, 2006. Title.

2. (1) The person listed in column 1 of the Schedule is granted an exclusive licence to import used tyres in the quantities listed in column 2 of the Schedule. Grant of exclusive licence.

(2) The exclusive licence referred to in subparagraph (1) shall be valid for six months only, from the date of commencement of this Order.

(3) If the licence expires before the person listed in column 1 has imported the number of used tyres authorised by the licence, that person shall forfeit the remainder of the tyres not imported.
