Section 19(d) is reprinted as follows with the error  
corrected—

#### “19. Emblezzlement.

A person who being—

- (a) an employee, a servant or an officer of the Government  
or a public body;
  - (b) a director, an officer or an employee of a company or a  
corporation;
  - (c) a clerk or servant employed by any person, association  
or religious or other organisation; or
  - (d) a member of an association or a religious organisation  
or other organisation,
- steals a chattel, money or valuable security—

- (i) being the property of his or her employer, association,  
company, corporation, person or religious organisation  
or other organisation;
- (ii) received or taken into possession by him or her for or  
on account of his or her employer, association,  
company, corporation, person or religious organisation  
or other organisation; or
- (iii) to which he or she has access by virtue of his or her  
office;

commits an offence and is liable on conviction to a term of  
imprisonment not exceeding fourteen years or a fine not  
exceeding three hundred and thirty six currency points, or both”.







IN EXERCISE of the powers conferred on the Minister by section 4(1) of the Gaming and Pool Betting (Control and Taxation) Act, Cap. 292, this Order is made this 12th day of January 2010.

**1. Title.**

This Order may be cited as the Gaming and Pool Betting (Control and Taxation) (Gaming and Pool Bets Tax) Order, 2010.

**2. Commencement.**

This Order shall be deemed to have come into force on 30th June, 2009.

**3. Rate of Tax.**

(1) Every promoter of gaming and pools promoted within Uganda and every principal agent of a promoter of gaming and pools promoted outside Uganda shall pay a tax rate of 15 percent of the total amount of money received or of the total amount of bets.

(2) Losses incurred in the generation of income shall be allowable deductions with regard to the gaming and pool betting promoted in Uganda.

**The Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2010.**

*(Under sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361).*

IN EXERCISE of the powers conferred upon the Minister responsible for transport by sections 135 and 175 of the Traffic and Road Safety Act, Cap. 361, this Order is made this 19th day of January, 2010.

**1. Title.**

This Order may be cited as the Traffic and Road Safety (Speed of Motor Vehicle) (Exemption) Order, 2010.

**2. Exemption.**

A person who drives a motor vehicle and competes in the All Stars Race 2010, organised by the Federation of Motor Sports Club of Uganda (FMU), in conjunction with the organising committee of UMX Club scheduled to take place on 24th January, 2010 at Shell Racing Track Garuga in Wakiso District is exempted from the provisions of section 120 of the Traffic and Road Safety Act.

**3. Maximum speed limit.**

A person who drives a motor vehicle and competes in the All Stars Race 2010 mentioned in paragraph 2, shall not exceed a maximum speed of one hundred and sixty kilometers per hour, for the duration of the rally.
